If I fail to answer any question or give false information, Rental Solutions may reject my application, retain all application fees as liquidated damages for its time and expense, and terminate my right of occupancy.

Applicant(s) has read and understands the above statement and to the best of his/her knowledge states that all facts are true and correct. It is further understood that a credit report and complete verification will be issued by an independent agent. Any applicable application fees must be paid prior to processing of the application and are non-refundable.

Rental Solutions offers occupancy to the first approved application. Holding Deposit is optional, and reserves a tenant's place in application processing line in the event of an application being delayed. Holding Deposit of \$250.00 is refundable if tenant is rejected for occupancy by Rental Solutions. Holding Deposit will not be refunded if occupancy rights are offered to tenant, and for any reason tenant does not accept, or accepts and is unable to occupy within a period of time acceptable to Rental Solutions. Upon an approved Rental Application, tenant's Holding Deposit is applied to tenant's Security Deposit.

Rental Solutions utilizes a credit scoring system that incorporates a statistical model comparing information on tenant's credit profile, such as bill-paying history, the number and type of accounts, late payments, collection actions, outstanding debt, reported rental history, and the age of accounts, to the credit performance of consumers with similar profiles. (A credit scoring model only uses information on the applicant that pertains to credit, it does not use certain characteristics like - race, color, religion, sex, national origin, handicap, or familial status in its calculation.) The scoring system awards points for each factor and considers income, monthly rent, & overall credit history to evaluate how creditworthy tenant is. Income and rental history are also factors taken into consideration when reviewing a tenant application. I understand that if I am applying for a unit along with other individuals, that my credit and/or other aspects of my Rental Application may be discussed with the other individuals applying for the unit along with me.

Authorization to Release Information to Prospective Property Manager
